- **You may have read that the DRE guidelines are changing and that you will no longer be permitted to take all exams in one day. This is a change that will be coming, but existing companies such as Charlie Krackeler Presents have approximately 6 months before that guideline affects their courses. This course will be completed and offered under the existing guidelines.**
- **You can take this class even if you do not need to renew your license for years. Just keep the certificate in your files and then send it in when you renew your license.**
- **Even if you renewed your license last month, you can still take the course and use the renewal certificate the next time around.**
